### TERMS AND CONDITIONS

1. You must be a financial member of the GWC in order to place an item for sale at the Shed Shop
2. You must pay the flat quarterly Shed Shop fee prior to, or with your submission, which includes this completed form.
3. All items submitted for sale will be logged on our Inventory & Payment Record. All sales will also be tracked here.
4. We do not pay commissions, pro-rata fees or accept IOU's.
5. Quarterly fees are not refundable except under rule 8
6. Quarterly fees are:
 

Q1 July to September	\$15
Q2 October to December	\$15
Q3 January to March	\$15
Q4 April to June	\$15

Please note the first "quarter" will run from 08/03/2026 to 30/06/2026.
7. All items must be hand made by you (the member) only. I.e. you may not place items for sale for family members or friends.
8. Items for sale must not show offensive language or pictures. Items of a political nature will also not be accepted.
9. The GWC reserves the right to refuse to put up your item for sale. If your item is refused and you had no other items for sale in that same quarter, your quarterly Shed Shop fee will be refunded.
10. There is no limit to the number of items you may put up for sale. You will only pay one quarterly flat fee.
11. Every item you put up for sale must and will be listed on our Inventory & Payment Record. You may add items throughout the quarter.



12. Please do not place price tags on your items. Please indicate the sale price for each item in the notes section below. To create uniformity, GWC price tags will be added to your item.
13. You may not advertise your own business, or any other business, on items for sale
14. Items on display may be moved around from time to time to create visual interest. All members will treat items for sale with respect and care.
15. Payment to members for sold items will be made in the month following the quarter in which it was sold. E.g.

16. We only accept cash payments at this time. We will investigate accepting digital payments in the future.
17. All cash payments received MUST be given a receipt from the specified duplicate receipt book regardless if the purchase is for goods OR for a quarterly fee.
18. Payments for items sold will be made into your nominated bank account as above.
19. All members with items for sale in the Shed Shop must agree to be rostered on to man the Shed Shop at least one shift per quarter. Date, time and length of shift to be agreed by both parties.
20. The Shed Shop Coordinator's say is final.
21. These rules may be updated from time to time without notice. Please ensure you obtain the latest rules
